The Bush Barn Art Center in Salem, Oregon invites established and emerging visual artists to submit artwork, fine and functional crafts, handmade gifts, tree ornaments, apparel and accessories to an all-media showcase in the A.N. Bush Gallery. (Artists participating in our Fall-Winter Exhibition Season at the Bush Barn Art Center are also welcome to apply with a different product line or series of work.)

ELIGIBILITY

- NO ENTRY FEE to submit work for consideration.
- Only works completed in the last two years.
- All mediums will be considered. For example:
 - Original works of art and/or matted and/or framed limited-edition reproductions, signed by the artist, and accompanied by a certificate of authenticity.
 - Handmade gift items, tree ornaments, crafts, apparel, accessories or jewelry designed and created by the artist.
 - Greeting cards, calendars, mugs, t-shirts or other licensed merchandise bearing graphic designs or art images produced by the artist will be reviewed on an individual basis.

All art and handmade merchandise will be offered for sale with a 50% commission paid to the artist and 50% to SAA's Galleries Program. Retail prices should include this commission split. Commissions help sustain SAA's non-profit arts programming, exhibition publicity, and operating costs.

PRESENTATION REQUIREMENTS FOR HOLIDAY SHOWCASE ARTISTS PLEASE READ CAREFULLY

These specifications have been developed by the gallery staff to ensure that exhibitions are sources of pride for the participating artists, as well as for our members and community. The quality of your presentation impacts how your work is viewed. Artwork that does not conform to the specifications below will not be accepted.

TWO-DIMENSIONAL ARTWORK

- Two-dimensional work can measure 48" or less on any side, inclusive of frame, and should weigh less than 20 lbs.
- No wet paint or recently varnished work; allow enough time for your piece to dry before delivery.
- No bare canvas edges with staples showing; canvas wrapped edges with no staples visible are acceptable.
- Quilts and other wall hangings must have sleeves or tabs for hanging from a rod; a rod of adequate diameter and quality must accompany your work. A quilt hanger may also be used.
- No dirty or scratched frames or unstable or loosely joined frames. No clip or clamp frames unless approved by the gallery staff prior to the exhibition. Attach art securely within the frame. Use hanging wire or strap hooks only; please, no saw tooth hangers, thread, string, twine or fishing line. Hanging wire should not appear above the top of your frame.
- Matting must be clean, free of debris and properly cut to professional standards. Single, cotton rag white, black or neutral tones are recommended; avoid bright colors or thin paper mats. SAA recommends matting measuring at least three inches per side.

THREE-DIMENSIONAL ARTWORK

• Three-dimensional work must measure 36" or less on any side and, unless prior approval is obtained from SAA, should weigh less than 40 lbs.

ADDITIONAL CONSIDERATIONS

Contemporary approaches to art-making may involve alternative presentations. If you employ alternative presentation methods, materials and assembly must be of the highest quality. SAA does not accept artwork with content that is pornographic, violent or gratuitously offensive. SAA does not accept work composed of materials that are caustic, poisonous, self-destructing or otherwise dangerous. SAA will not be liable for any damage to artwork framed with glass. For security and aesthetic purposes, artists may not include their contact information on the face of the artwork.

By submitting this application, I understand that SAA may use images of my work to help promote the exhibition online and/or in print.
